JOINT STIPULATION OF DISMISSAL WITH PREJUDICE

Plaintiffs, Englewood Church of the Nazarene, Inc. and Englewood Christian School, Inc., and Defendant, Sarasota County, Florida, have entered into a settlement agreement. The Defendant has granted Englewood Church of the Nazarene, Inc. a special exception to operate Englewood Christian School, Inc. at 404 West Green Street, Englewood, Florida 34223. Additionally, the lien on Englewood Church of the Nazarene, Inc.'s property has been released and all accrued fines have been waived by the special magistrate. In entering into this settlement agreement, no party admitted to any liability or wrongdoing.
